## NZ Funds Advised Portfolio Service Dividend and Growth Portfolio

### What is the purpose of this update?

This document tells you how the Dividend and Growth Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. New Zealand Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The objective of the Dividend and Growth Portfolio is to grow your investment over the long term. The fund is anticipated to hold mainly Australasian shares.

### What are the risks of investing?

Risk indicator for the Dividend and Growth Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

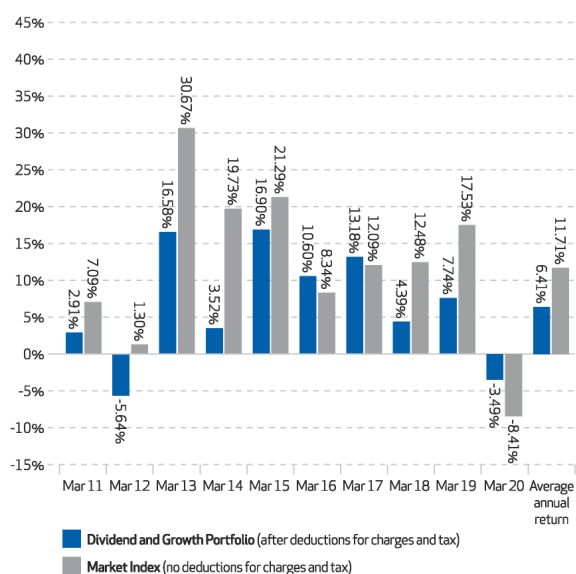

### How has the fund performed?

## What fees are investors charged?

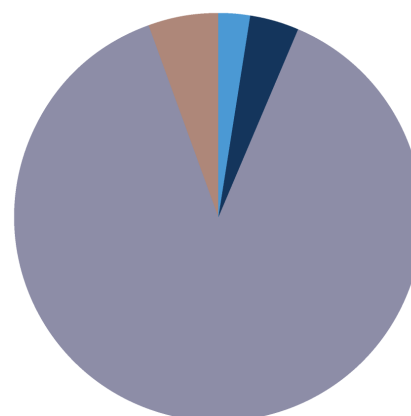
## Example of how this applies to an investor

Liam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Liam incurred a loss after fund charges were deducted of -\$349 (that's -3.49% of his initial \$10,000). Liam did not pay any other charges. This gives Liam a total loss after tax of -\$349 for the year.

The top 10 investments make up 76.52% of the fund.<sup>3</sup>

NZ Funds actively manages the foreign currency exposure of the fund. Where the fund holds assets denominated in a foreign currency, NZ Funds has the choice of whether to hedge back to the NZ dollar or retain a foreign currency exposure. The fund may also take active foreign currency positions by holding non-NZD cash and/or foreign currency derivatives. As at 31 March 2020, the fund's foreign currency exposure was 5.37%.
