What is the purpose of this update?

This document tells you how the Global Equity Growth Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. New Zealand Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The objective of the Global Equity Growth Portfolio is to grow your investment over the long term. The fund is anticipated to mainly hold international shares.

Total value of the fund \$169,565,616

The date the fund started 31 October 2008

What are the risks of investing?

Risk indicator for the Global Equity Growth Portfolio:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

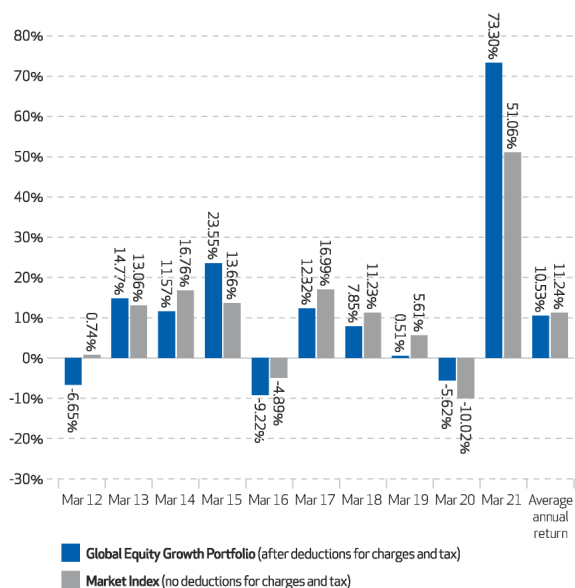

What fees are investors charged?

Investors in the Global Equity Growth Portfolio are charged fund charges. In the year to 31 March 2021 these were:

*Note: Included within 'Other management and administration charges' are performance-based fees charged by external managers of underlying funds that the fund invested into which totalled 1.33%. Performance-based fees are subject to market movements and manager performance and the amount of these fees for any given period may materially differ from those disclosed for the year to 31 March 2021. For the 12 months to 30 June 2021, external manager performance fees were 1.32% and NZ Funds' performance fee was 7.78%. As a result, total fund charges for that period totalled 12.34%.

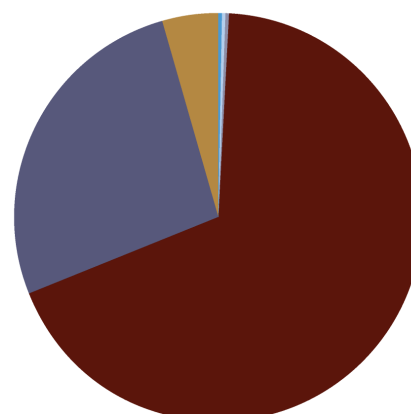
Example of how this applies to an investor

Liam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Liam received a return after fund charges were deducted of \$5,371 (that's 53.71% of his initial \$10,000). Liam did not pay any other charges. This gives Liam a total return after tax of \$5,371 for the year.

The top 10 investments make up 49.40% of the fund.⁶

NZ Funds actively manages the foreign currency exposure of the fund. Where the fund holds assets denominated in a foreign currency, NZ Funds has the choice of whether to hedge back to the NZ dollar or retain a foreign currency exposure. The fund may also take active foreign currency positions by holding non-NZD cash and/or foreign currency derivatives. As at 30 June 2021, the fund's foreign currency exposure was 48.97%.

Notes

1. The bar graph shows fund returns after the deduction of fees and tax; however, the market index returns are shown before any fees or tax are deducted.
2. Other management and administration charges comprise:
 - (a) operating costs directly incurred by the fund; and
 - (b) annual management fees, performance-based fees and operating costs incurred by underlying funds the fund invests into.

Estimates were used when deriving annual management fees, performance-based fees and operating costs incurred by the following underlying funds the fund invested into.

3. Total performance based fees are paid with respect to certain related underlying funds managed by NZ Funds and are payable where performance of the underlying funds exceeds the hurdle rate. Details of the underlying funds to which a performance fee applies can be found in the PDS, along with details of the hurdle rate and the percentage amount of the performance fee applying to each underlying fund.
4. NZ Funds uses derivatives as part of its active management approach. The use of derivatives can result in the total economic exposure of the fund exceeding 100% which means the fund is leveraged. Where economic exposure exceeds 100%, the actual investment mix pie graph has been scaled to 100%.

Without scaling, the total economic exposure of the fund, as shown in the actual investment mix would be 190.33%, made up as follows: Cash and cash equivalents 1.00%; International fixed interest 0.24%; Australasian equities 0.41%; International equities 129.68%; Commodities 50.66% and Other 8.34%.
