What is the purpose of this update?

This document tells you how the Growth Strategy has performed and what fees were charged. The document will help you to compare the fund with other funds. New Zealand Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The objective of the Growth Strategy is to grow your investment over the long term by investing in income and growth assets using an active management approach. It is anticipated that the fund will mainly hold Australasian and international shares, and/or hedge funds. It may also invest in other permitted assets.

Total value of the fund \$175,724,740

Number of investors in the fund 7,916

The date the fund started 1 November 2010

What are the risks of investing?

Risk indicator for the Growth Strategy:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

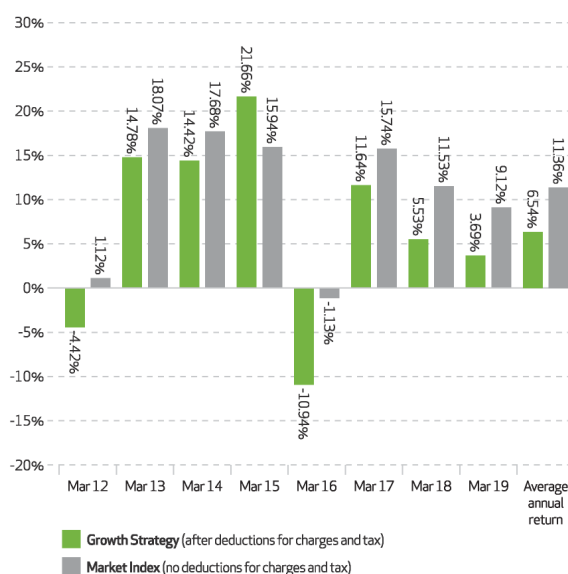

How has the fund performed?

*Note: Included within 'Other management and administration charges' are performance-based fees charged by managers of underlying funds that the fund invested into which totalled -0.03%⁴. Performance-based fees are subject to market movements and manager performance and the amount of these fees for any given period may materially differ from those disclosed for the year to 31 March 2019. For the 12 months to 30 June 2019, external manager performance fees were 0.09% and 'Total fund charges' for the period were 1.63%.

[†]From 1 April 2019, a performance-based fee may be charged in a related underlying fund. For more information, see the PDS.

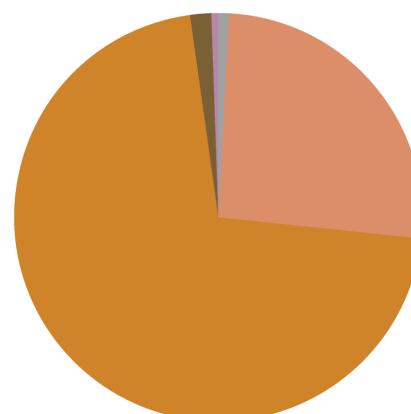
Example of how this applies to an investor

Liam had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Liam received a return after fund charges were deducted of \$138 (that's 1.38% of his initial \$10,000). Liam also paid \$36 in other charges. This gives Liam a total return after tax of \$102 for the year.

The top 10 investments make up 52.48% of the fund.⁷

NZ Funds actively manages the foreign currency exposure of the fund. Where the fund holds assets denominated in a foreign currency, NZ Funds has the choice of whether to hedge back to the NZ dollar or retain a foreign currency exposure. The fund may also take active foreign currency positions by holding non-NZD cash and/or foreign currency derivatives. As at 30 June 2019, the fund's foreign currency exposure was 14.14%.

Notes

1. The bar graph shows fund returns after the deduction of fees and tax; however, the market index returns are shown before any fees or tax are deducted.
2. Other management and administration charges comprise:
 - (a) operating costs directly incurred by the fund; and
 - (b) annual management fees, performance-based fees and operating costs incurred by underlying funds the fund invests into.

Estimates were used when deriving annual management fees, performance-based fees and operating costs incurred by the following underlying funds the fund invested into.

Fund	Information and assumptions used to make estimates
Suvretta Offshore Fund	The fee and operating cost amount obtained from the manager of the fund was for the year to 31 December 2018. Performance fee amounts are estimated using the same criteria used by the administrator of the fund.
Impala Resource Fund	Fee and operating cost amounts are estimated using fee targets provided by the manager of the fund for the year to 31 December 2018. Performance fee amounts are estimated using the same criteria used by the administrator of the fund.

3. The NZ Funds KiwiSaver Scheme has an administration fee of \$3.00 per investor per month.
4. In the 12 month period to 31 March 2019, there was a reversal of external manager performance fees that had been accrued in the previous year.
5. NZ Funds uses derivatives as part of its active management approach. The use of derivatives can result in the total economic exposure of the fund exceeding 100% which means the fund is leveraged. Where economic exposure exceeds 100%, the actual investment mix pie graph and the target investment mix table have been scaled to 100%. Without scaling, the total economic exposure of the fund, as shown in the actual investment mix and the target investment mix, would be 103.08% and 103.00% respectively. 6. The fund is able to invest in a wide range of assets and does not have a target investment mix. For the purposes of this update, the target investment mix has been compiled using the actual investment mix. NZ Funds is an active investment manager and as a result the actual investment mix and target investment mix will change in the future and changes may be material.
7. The top 10 investments have been compiled using a balance sheet approach. This differs from the approach used in compiling the actual and target investment mixes, which include the impact of derivatives.
