

# Investment update

## NZ Funds KiwiSaver Scheme LifeCycle Process - age 75

This fund update was first made publicly available on 1 May 2019

### What is the purpose of this update?

This document tells you how the LifeCycle Process - age 75 investment option has performed and what fees were charged. The document will help you to compare the investment option with other investment options. New Zealand Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this investment option

The objective of the LifeCycle Process is to allocate your investment across the three funds (Strategies) in the Scheme based on your age to ensure that your investment is allocated in a manner that is consistent with your investment timeframe. At age 75, your investment will be allocated as follows: 35% to the Income Strategy; 34% to the Inflation Strategy; and 31% to the Growth Strategy.

### What are the risks of investing?

Risk indicator for the LifeCycle Process - age 75:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the investment option's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

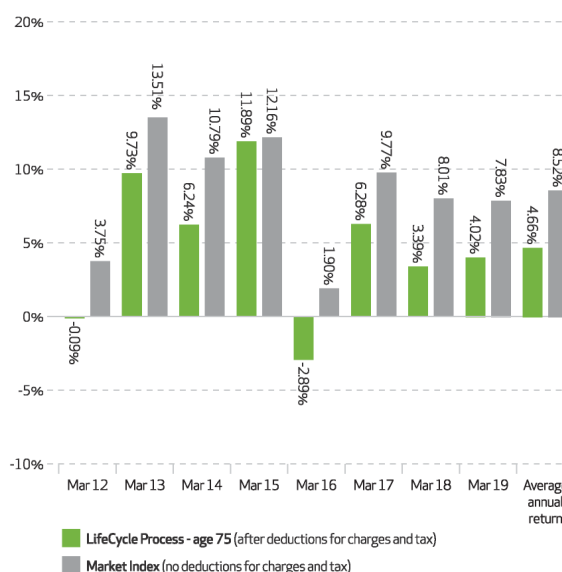

### How has the investment option performed?

#### Annual return graph<sup>2</sup>



This shows the return after fund charges and tax for each year ending 31 March since the investment option started. The last bar shows the average annual return since the investment option started, up to 31 March 2019.

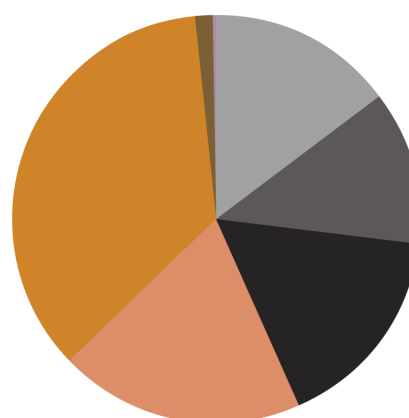
## Example of how this applies to an investor

Liam had \$10,000 in the investment option at the start of the year and did not make any further contributions. At the end of the year, Liam received a return after fund charges were deducted of \$402 (that's 4.02% of his initial \$10,000). Liam also paid \$36 in other charges. This gives Liam a total return after tax of \$366 for the year.

The top 10 investments make up 47.85% of the investment option.<sup>8</sup>

NZ Funds actively manages the foreign currency exposure of the investment option. Where the investment option holds assets denominated in a foreign currency, NZ Funds has the choice of whether to hedge back to the NZ dollar or retain a foreign currency exposure. The investment option may also take active foreign currency positions by holding non-NZD cash and/or foreign currency derivatives. As at 31 March 2019, the investment option's foreign currency exposure was 11.79%.

## Notes

1. The total value and number of investors in the NZ Funds Kiwisaver Scheme Lifecycle Process overall is \$211,321,118 and 7150 respectively.
2. The bar graph shows investment option returns after the deduction of fees and tax; however, the market index returns are shown before any fees or tax are deducted.
3. Other management and administration charges comprise:  
(a) operating costs directly incurred by the investment option; and  
(b) annual management fees, performance-based fees and operating costs incurred by underlying funds the investment option invests into.

Estimates were used when deriving annual management fees, performance-based fees and operating costs incurred by the following underlying funds the fund invested into.

4. The NZ Funds KiwiSaver Scheme has an administration fee of \$3.00 per investor per month.
5. In the 12 month period to 31 March 2019, there was a reversal of external manager performance fees that had been accrued in the previous year.
6. NZ Funds uses derivatives as part of its active management approach. The use of derivatives can result in the total economic exposure of the investment option exceeding 100% which means the investment option is leveraged. Where economic exposure exceeds 100%, the actual investment mix pie graph and the target investment mix table have been scaled to 100%. Without scaling, the total economic exposure of the investment option, as shown in the actual investment mix and the target investment mix, would be 107.54% and 107.62% respectively. For more information on economic exposure, see the PDS.
7. The investment option is able to invest in a wide range of assets and does not have a target investment mix. For the purposes of this update, the target investment mix has been compiled using the actual investment mix. NZ Funds is an active investment manager and as a result the actual investment mix and target investment mix will change in the future and changes may be material.
8. The top 10 investments have been compiled using a balance sheet approach. This differs from the approach used in compiling the actual and target investment mixes, which include the impact of derivatives.
