## Changes relating to the Scheme

### Governing document

There were no amendments to the Scheme's Trust Deed during the year.

### The terms of the offer of interests in the Scheme

As a result of a legislative change, from March 2021, members with life-shortening congenital conditions, as prescribed by the KiwiSaver Regulations, may withdraw from the Scheme before the age of eligibility for national superannuation.

### Statement Of Investment Policy and Objectives (SIPO)

On 21 October 2020, the SIPO was updated to:

- remove economic exposure limits for the Strategies;
- update target asset allocations for the Strategies;
- reflect additional exclusions under NZ Funds' Responsible Investment Policy; and
- update the Glossary by adding cryptocurrencies as an example of 'Alternative securities'.

### Related party transactions

There were no material changes to the nature or scale of the related party transactions for the Scheme.

All related party transactions during the year were conducted on arm's-length terms.
